Shinoken accelerates DX Subsidiarizing Computer System (CSC)

Shinoken Office Service (Further referred to as SKO), a subsidiary of Shinoken Group Co., Ltd. (Tokyo Headquarters: Minato-ku, Tokyo, President Hideaki Shinohara, TSE Ticker 8909, further referred to as Shinoken, including the whole group) has acquired all shares and subsidiarized Computer System Co., Ltd. (Headquarters: Shinjuku-ku, Tokyo, CEO Keiichi Tamura, further referred to as CSC) as of today, February 26th, 2021. First, CSC will join the SKO Information System Office in promoting the renewal of Shinoken's core systems and support the development of next-generation systems, while working with REaaS Technologies (<https://www.reaas.tech/>) and its subsidiary POINT EDGE Corporation (<https://pointedge.work/>) to accelerate development projects for the Trust DX Platform and various applications.

In addition, CSC's strength in engineer education and SES business will

enable the continuous training and acquisition of engineers within Shinoken, and acquiring CSC will strengthen our development capabilities in the real estate tech field in a comprehensive manner.

By leveraging group synergies, we will accelerate the realization of REaaS, provide services that transcend generations and borders, and work to achieve our vision of becoming "A life support company for every generation across the world" as soon as possible.
