Shinoken strives to realize a sustainable society Offsetting CO2 emissions from all company vehicles

Shinoken Group Co., Ltd. (Tokyo Headquarters: Minato-ku, Tokyo, President Hideaki Shinohara, TSE JASDAQ Code: 8909, hereinafter referred to as Shinoken, including the whole group), as part of the efforts to build and promote a sustainable society and business, has offset (effectively reduced to zero) the 324 tons of CO2^{*1} emitted from the 144 company vehicles in one year, through the J-Credit Scheme.

Government target: "Carbon neutral by 2050

As part of our efforts to decarbonize, we will reduce CO2 emissions from all company vehicles in our group to virtually zero

Shinoken has been considering specific actions to contribute to the achievement of the government's goals of "carbon neutrality by 2050" and "46% reduction of new greenhouse gas emissions in FY2030 compared to FY2013".

As part of these efforts, we have offset (effectively reduced to zero) the 324 tons of CO2 emitted from the 144 company vehicles, including the Group's sales vehicles, in one year, through the J-Credit Scheme^{*2}, a governmental system.

Along with continuing with this initiative, we will accelerate the introduction of Electric Vehicles for company cars, which we started in 2020, and switch power consumption of all our offices, including the head office, to electricity derived from renewable energy sources, as part of our sustainable business activities.

Various actions in both Japan and overseas

Shinoken's main products are wooden buildings that are carbon-neutral in nature, and as a company operating in Indonesia, Shinoken has acknowledged the issue of deforestation of tropical rainforests, etc. The Group is working to address global warming and climate change in Japan and overseas by promoting the development of wooden building apartments, introducing EV company cars, and planning to plant tropical rainforests in Indonesia. In addition, since 2017, we have been focusing on

biomass power generation using wood chips, which is one of the most carbon-neutral forms of renewable energy, and have been promoting the planning and development of power plants through our affiliated company in an effort to spread renewable energy.

In addition to evolving as a company that reduces and sequesters CO₂ and achieves carbon neutrality, Shinoken aims to maximize its corporate value by contributing to the realization of a sustainable society through various actions, including renewable energy.
